Minutes of the Parish Council Meeting held on Monday 17^{th} March 2025. This meeting was held in Otley Village Hall (Back Room).

AGENDA

- 1.) Chairman's Welcome, Apologies and Approval of Absences. Apologies received from Mrs Abigail Lord (ABL) Mr Mike Bowers (MB) and County Councillors Elaine Bryce (EB) Councillors accepted these apologies.
- 2.) To receive Declarations of Interest and Consider requests for Dispensations None
- 3.) Public Forum (For any matters on the Agenda) Item 7 Other Matters b Hand Bell Ringers request for funding was discussed. Mrs Jenny Ellis provided a history of the hand bells. The group has been running since the 1990's initially they had fourteen bells but over time have purchased additional ones via generous donations from members or gifts of a bell in memory of a loved one to give a total of twenty-six which comprise of two octave chromatic set enabling a wide repertoire of pieces. The group meet weekly during term time either practising or going out entertaining in various venues within the local area including special interest clubs, residential and nursing homes as well as having played at funerals of local Otley residents. Generally the group is self sufficient members pay a subscription and a fee of £25 is charged to the venues they play at. Any surplus funds donations are given to an annual chosen charity, in the past they have domination to St Elizabeth's Hospice, Air Ambulance, Guide Dogs etc. Half of the bells are over thirty years old, so at last years AGM it was decided that some of the bells needed a complete overhaul due to the fact they have been well used, felts were worn, clappers were becoming loose and wobbly and handles and caps thin and worn. The twelve worst bells were sent to Whitechapel Bell Foundry at a cost of £1,723 the club only has reserves of £600. The group have received a donation of £500 from the Church and an interest free loan which is gradually being repaid. A further six of the older bells will need refurbishment in the very near future for which some fund raising will need to take place as well as explore grant applications. The bells will continue to be well used and provide great pleasure to the members and the audience they entertain. The Otley Bell Ringers are widely known so any financial help would be much appreciated. Following a discussion it was agreed that the Parish Council would fund £625 All in favour Proposed by GG and Seconded by CG. Going forward Clerk will provide Otley Bell Ringers with details of any possible grants that can be applied for.
- 4.) To resolve that the minutes of the Parish Council Meeting held on Monday 20th January 2025 are a true and correct record. There was a correction to these minutes under item 6 Matters Arising Neighbourhood Plan to remove the word Referendum but keep the word Consultation. This was done Minutes were then agreed and signed. Proposed by GG and Seconded by MH.
- 5.) To receive reports from Elaine Bryce County Councillor & District Councillor Dan Clery. These were circulated prior to this meeting.

6.) MATTERS ARISING - To receive progress on the following -

a) Neighbourhood Plan Regulation 16 Consultation and Inspection.- An Inspector has now been been appointed, to follow on from the Regulation 16 Consultation which is due to be completed on the 9th April. He is appointed to The Neighbourhood Plan Independent Examiners Referral Service (NPIERS) GG still has some hard copies available of the Neighbourhood plan (Inspection Version) If anyone would like a copy. Clerk has been contacted by a couple of residents asking for more details about the plan, they have been directed to the PC Website along with links to East Suffolk Council. It was agreed that a copy of the plan would be put in the village store. Posters have already been put up on the notice boards to advertise of the Regulation 16 Consultation.

Dan Clery (DC) arrived at 7.55pm and give his report, devolution and reorganisation has been the main area for discussion. It continues to be felt that District Councils are an important link to Parish Council, over the year it had been of great value to Otley Parish Council to have a District Councillor to link up with over local matters such as planning. The Scrutiny committee is due to look at the value of Community Partnership. Do we feel they are of good value? Otley has not had a great deal to do with the Partnership, it tends to operate better in the larger populated areas, such as Rendlesham, Kesgrave, Martlesham, Rushmere etc. Whereas the smaller rural villages do not appear to get as included or what Community Partnership have on their agenda is relevant to those smaller communities. There was a proposal to set up a bus service to Woodbridge via Grundisburgh which would be useful, this was something that residents raised when we had the Consultation Day at the Village Hall for the Neighbourhood Plan. It is appreciated that these things depend on the demand. There is supposed to be more money coming via central government for rural transport. DC agreed to take back the views expressed regarding a bus service to Woodbridge. DC left the meeting at 8.10pm

- b) Sport and Play Fund Following a recent meeting the Community Council is now at the stage were they should be able to put an application in, for all the items that have previously been highlighted. There are still a couple of further quotes to come through. Once the application has been submitted it should take around 20 days to make the decision. It is hoped that if possible the Car Park will be resurfaced over the Summer and the play equipment put in place around the same time, as well as the monies made available to the Bowls Club to purchase their new mower. Regarding the consultation with the village it was felt that because the Community Council is made up of all the different organisation that use the Village Hall and they feedback to the various individual groups this in itself forms a consultation. It was discussed that AL would check and discuss this approach with Sarah Shinnie from East Suffolk Council who is responsible for overseeing this grant and how it is spent.
- c) Village Hall Roof / Grants The grant that the Community Council recently applied for the roof was not successful. There were 12 applications and only 5 received grants. It was felt that we should still proceed. We have circa £40,00 from the Parish Council CIL monies which will cover the cost of the new roof and the Community Council have agreed to use some of their funds to pay for the demolition work and asbestos removal which comes to £14,000. The works are booked in to start on 7^{th} April, scaffolding will be put up the week before, the asbestos survey has been completed and paid for by the Parish Council. The works should be done within 2 weeks. The hirers of the hall have already been advised that the hall will be out of action for the two weeks. The builders will shut off the front of the hall across, and make a compound. There will be access to the playing field, bins and parking for the Doctors Surgery.
- d) Dog Bin along Helmingham Road Clerk contacted East Suffolk Council to enquire on the progress of the Dog bin that was requested for Helmingham Road, received notification that the bin was installed on 17th February 2025. Advised that invoice should be received shortly.
- e) Old Map of Village This has now been framed and collected. Would be nice to have C Child and family to unveil at the Summer Fete. Thank you CG for organisation the framing.
- f) Grit Bin on Otley Hill At last meeting County Councillor EB offered to speak Highways regarding them reconsidering the emptying and removal of this bin because of where it is sited and access it is dangerous. Following this offer from EB Clerk sent them details of the situation but as yet has not heard anything back. It was discussed now that the weather was better whether if and when a road closure occurs if it would be possible to at least drill some holes in the bin to get rid of the water. Also mention that Mr K Bailey has stood down as a Volunteer Grit Bin person on Ipswich Road. A letter of thanks was sent to Mr Bailey for his many years service in this role. Mr and Mrs Wells have kindly agreed to take over from him. They have been made aware that for insurance purposes they need to wear hi vis when spreading the salt on the road.
- g) Deer Signs Following last meeting Clerk emailed contact with Highways regarding if it was possible to have some temporary signs. They responded "that this was not something that Suffolk is able to provide. There are a couple of parishes that have put up informal signs on private land (not the highway verge) warning of deer in some areas. If Otley Parish Council were to put such signs up they would clearly need to be off the public highway, otherwise they could well be removed by Highways Enforcement Team. Outside of this Highways have checked their reporting system and there have been no further reports of incident or request for deer signs in the areas, which could indicate are they needed?

A Councillor advised that they are aware of a very recent incidence at Otley Bottoms of deer jumping into the road, that resulted in a car being written off. Following a discussion it was agreed that the Clerk would put something up on Facebook to ask if anyone has had experience of incidences of Deer Crossing at Otley Bottom such as collision, near miss, insurance claim, costs write off etc so we have the evidence to go back to Highways and asked how best to report these incidence.
